DIRECT CREMATION

The Direct Cremation option is for those families who wish to arrange a cremation with the limited services of the funeral home and licensed funeral director. The funeral home and licensed funeral director will handle **only** the items that are necessary for the final disposition of their loved one. **This option does not include any Public Viewing or Funeral Services.**

- Professional services of licensed funeral director and staff with 24 hour availability.
- Basic involvement of Licensed Funeral Director to secure and the filing of all necessary authorizations and permits as required for final disposition.
- Transportation of the deceased to the funeral home (within 10 miles).
- Shelting of remains for a minimum of 48 hours.
- Preparation, care and disinfection techniques of the deceased in accordance to WI State Statute H.H.S. 136.04.
- Family secures cremated remains that are in a temporary container at the funeral home.

This choice **does not** include coroner's cremation permit fee, cremation fee, death certificates, obituaries in newspapers or cemetery charges, alternative container of cremation casket of your choice.

- Transportation of the deceased to the funeral home (within 10 miles).
- Shelting of remains at funeral home for a minimum of 48 hours.

- Full coordination of staff for a same day Memorial Service at Funeral Home, Place of Worship or other location under the direction of a licensed Funeral Director (with or without urn present).

- Services of licensed Funeral Director at Committal Service or dignified return of cremated remains to the family within a 25 mile radius.
